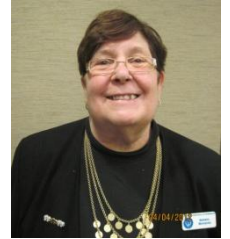

Grants for Women deadline was January 31, 2012. We received 47 applications for Western Canada and 520 for Eastern Canada.

The National Judges were:

Sue Baldauf is a home economist retired from a long career as a secondary school Family Studies teacher/dept head. In Brantford, she promoted day care and parenting programs for teen moms and worked with community nutrition education programs. Susan promoted Family Studies as a member of the provincial Family Studies Subject Council, writing curriculum, mentoring new teachers, and facilitating teacher professional development. In her retirement, she works with quilting guilds and the Women's Institute.

Marion Logan has been a feminist all of her life. After raising 3 sons, she was employed as Executive Director of a YWCA, as a staff person at the Women's Desk at the National Office of the United Church of Canada, and as a faculty member at Conestoga College teaching Employment Preparation Programs. Her favourite at the College was empowering single Moms. Marion has also done a great deal of international volunteer work. She was very impressed by the high quality and commitments of the applicants for the Soroptimist Bursaries.

Gail Russell is a retired nurse. She grew up in Northern Ontario and attended a local hospital with affiliation at Sick Children's Hospital and at the Lakeshore Mental Health facility in Toronto.
